 - 4-way, 4-way female, 4-way VFS and 8-way
 - Artistic Events:
 - Freestyle and Freefly
- To determine the European standings of the competing teams;
- To establish Formation Skydiving and Vertical Formation Skydiving European Records;
- To promote and develop Formation Skydiving, Vertical Formation Skydiving and Artistic Events training and competition;
- To present a visually attractive image of the competition jumps and standings (scores) for competitors, spectators and media;
- To exchange ideas and strengthen friendly relations between the sport parachutists, judges, and support personnel of all nations;
- To allow participants to share and exchange experience, knowledge and information;
- To improve judging methods and practices.

Payment of Sanction Fees

Payment of Sanction Fee must be done in EUR. Equivalent amount is € 112, at an exchange rate of 1.0667 CHF/EUR.

Included in the entry fee

Competitor entry fees include opening ceremonies, competition costs, lunch each day during competition, closing ceremonies and banquet.

Entry fee for Heads of Delegation, Team Leaders and Other Delegation Members includes opening ceremonies, lunch each day during competition, closing ceremonies and banquet. All other expenses are the responsibility of the delegations.

Entry dates

The preliminary entry of a NAC for an FCE must reach the Organiser at least 75 days before the start of the competition – **deadline for preliminary entry: June 13th 2025**

The official entry of a NAC for an FCE must reach the Organiser at least 45 days before the start of the competition – **deadline for official entry: July 13th 2025**

Late registration may be accepted if capacity allows, and the registration fee will be increased by 20% (except the Sanction Fee which stays the same) – **deadline for late registration: August** 1st 2025

Registration procedure

Step 1 Each delegation's NAC is asked to send an e-mail with the list of approved delegation members to worldcup2025@skydiveteuge.com

Once received, the host will send the NAC an e-mail with the registration link for step 2.

Step 2 Registration will be online. Individual details are to be submitted the NAC. Further information will follow based on the details provided in the preliminary registration.

Payment procedure

For every registration an invoice will be created which includes all necessary banking information. Payments can be made through online payment methods or via bank transfer.

The whole amount of the section Entry Fees must be paid to the organiser.

Please note: All payments must be in EUR, all possible costs regarding exchange to EUR and international banking fees are to be paid by the registrant or the NAC. It is the responsibility of the registrant that the correct Euro amount is transferred to the organisation.

6 Dropzone facilities


Skydive Teuge is the largest dropzone in the Netherlands and has hosted several (National) Championships in the past, including the 2015 World Cup of Formation Skydiving. It has multiple classrooms, a training area, a rigging loft and a club bar on site. For the event, extra areas for the competitors will be created, such as creeper areas, packing areas and room for storing personal belongings.



Judging areas will be set up with ample space for the judging teams. Dubbing stations will be located near the judging areas in a separate room.

The IT-infrastructure at Skydive Teuge is capable of serving a large number of connected devices and offers a fast internet connection. During the competition a dedicated network for judges will be created. Competition staff can use existing infrastructure regarding computers and printers.

Showers and toilets are available in the main building. During the competition extra facilities will be provided at the competitors area.



7 Aircraft details



3X Cessna 208B Supervan are available for all events. All aircraft have one engine (900 shp), can seat a maximum of 18 skydivers with a left-hand door, all with the same dimensions. All aircraft have both rear and front video step with handles on the outside and inside.

Exit speed will be 80 kts (+/- 5kts) with a lift capacity of 3-4 loads per hour. Skydive Teuge is a professional (SPO) organisation, with highly skilled, current pilots who have experience flying at skydiving competitions. All aircraft have been fitted with a surplus of seatbelts, which are mandatory during take-off.

8 Pre-event

Skydive Teuge operates seven days a week starting April 1st until the end of October. Standard jump ticket prices are € 26, -. One training jump is included on the official practice days.

During the event Skydive Teuge has a NOTAM for FL140. Outside of the event Skydive Teuge has a permanent NOTAM to FL 130 with infrequent periods of limitation to FL 090.

13 Medical / emergency details

Skydive Teuge is closely situated to the cities of Apeldoorn and Deventer. Each have a hospital, located about 12 km from Skydive Teuge.

Average response time for emergency services is usually less than 15 minutes.

First aid kits and CPR trained personnel will be on site for the duration of the event.

14 Insurance details

All members of delegation are responsible for their personal travel insurance. This should include health, disability, repatriation and third-party liability insurance. The insurance must be valid in the Netherlands for possible claims following out of parachuting.

Any damages caused by any member of delegation is the responsibility of the people involved.

Skydive Teuge will not be held responsible for damaged, lost or stolen property.

 - Landing turns over 90 degrees will not be allowed during the event


Anti Doping Program

The Anti-Doping Program may take place at the event. If so - the doping tests are carried out by the official Anti-Doping organization or sample collection provider recognized and approved by World Anti-Doping Agency (WADA). The selection of athletes would be according to the 2021 FAI Anti-Doping Rules, which are based on 2021 WADA Code and are available at https://www.fai.org/anti-doping-rules-procedures.

After receipt of notification until arrival at the point of doping control the selected competitors will be always accompanied by chaperone assigned by the sample collection authority. The selected competitor may be accompanied by a person of their choice (team doctor, coach or head of delegation). If the Organizing Committee does not provide participants with accreditation with the photo on it, the selected athlete will be required to provide a valid passport or identity card at the point of doping control.

Note: Please carefully plan a departure date and time after the competition taking into the account that you may be chosen for the Doping Control.
