Technical reminder: The European Championship – Accuracy is to be held concurrently with the Skydiving World Cup Series (SWCS) round in the Czech Republic. Each competition is judged according to the respective rules, that differ from each other. The order of jumps in the individual rounds of the competition will be determined by the Meet Director according to the SWCS rules and Sporting Code SC5 5.2.2.2

The Sanction Fee is to be paid at a value in EUR that is no less than the conversion at the time of transfer, which is still 105 CHF = 113 EUR at the date of publication. ### 5. TRAINING DAYS

In the previously published Bulletin #1, the Pre-Event practice days were mentioned. The Pre-Event practice day is possible only from Saturday July 5<sup>th</sup>. Unfortunately, it is not possible to train before that date because the airport is booked by another party.

Monday July 7<sup>th</sup> is the S&A practice day (optional – if desired).

Training on Tuesday July 8<sup>th</sup> and Wednesday July 9<sup>th</sup> will be organized as far as the ongoing Style competition and weather permit. The organizers will facilitate these training jumps as much as possible.

### 6. OTHER MATTERS

6.1 If you have registered a Team Manager who is not also Team Captain and competitor, please make sure that this NAC Official holds a valid FAI Sporting Licence.

(see **FAI General Section 4.2.3 Team Leaders (or Team Managers)** "**Persons representing the team. They may be competitors. In First Category events, the team leaders are considered as competitors and must have a Sporting Licence.**")

6.2 The FAI Sporting Code 4.4.2 (4) requires that each delegation bring its own national flag (approximately 100 cm x 150 cm). National anthems are to be checked on registration by a representative (HoD) of each participating NAC.

#### 6.3 ANTI DOPING PROGRAM

The Anti-Doping Program may take place at the event and participants may be selected for "In Competition Testing" in accordance with <https://www.fai.org/anti-doping-rules-procedures>. Tests may take place at any time during the event (i.e. before the closing ceremony).

**Reminder:** All participants are required to submit to and to cooperate with doping control measures, for therapeutic use exemption (TUE) see FAI GS 4.4.2.4. and [Rules and Procedures | World Air Sports Federation](#)
