3 Any updates to information published in Official Bulletin #1

Participants shall pay attention to detailed information about accommodation and free shuttle from JingGangShan Airport to Hotel as informed below.

3.1 Accommodation

As the entry fee covers accommodation from official entry to exit, the rooms will be standard two-bed rooms. Rooms will be allocated according to the actual number of participants registered via official entry form by NACs and by genders.

If early check in and late check out occurs, the organizer will charge extra fees due to accommodation and food with contract price with the hotel.

If single rooms are required, extra fees will be charged due to the upgrading of rooms.

3.2 Free Shuttle

The local organizer offers free shuttles from JingGangShan Airport to Hotel three times a day and will try its best to satisfy all participants' landing time. Team leaders/managers/coaches please inform via entry E-mail the exact arriving and leaving flight and time for shuttle agenda. Failure to inform the organiser will be taken that a shuttle is not needed.

The local social traffic and taxi are also convenient.

4 Anti-Doping Program UNCHANGED

The Anti-Doping Program may be conducted during the event. If so, the doping testing is carried out by the official Anti-Doping organization or sample collection agencies authorized by the World Anti-Doping Agency (WADA). From receiving notification to arriving at the doping control point, selected athletes will always be accompanied by designated personnel from the sampling agency. The selected competitor may be accompanied by a person of their choice (team doctor, coach or head of delegation). If the organizing committee fails to provide the participating athletes with photo identification, the selected athletes will be required to provide a valid passport or ID card at the doping control point.

Please carefully plan a departure date and time after the competition taking into the account that you may be chosen for the Doping Control.

5 Insurance UNCHANGED

Each competitor must purchase at least one Third-party Liability Insurance with an amount of at least 1M RMB or the equivalent/same amount of other currencies valid in China.

Personal Health Insurance and repatriation coverage are the responsibility of each participant and is highly advisable.

6 Injury Protocol

Competitors are requested to bring the signed COMPETITOR VERIFICATION OF ACCEPTANCE OF FAI/ISC INJURY PROTOCOL form with them and present it at Registration.

COMPETITOR VERIFICATION OF ACCEPTANCE OF FAI/ISC INJURY PROTOCOL

This form must be completed by the Competitor prior to the start of the event.

In the event that the injury assessment procedure would clear me to return to competition without the requirement of a medical evaluation and I would accordingly decide to do so, I understand that the injury assessment procedure is not a medical procedure but only a screening process to potentially identify *prima facie* elements justifying to making a medical evaluation a required condition to return to competition. I recognize that the outcome of the assessment only confirms that the person who conducted it, and who I understand and accept is not medically trained, is making the observations reported in the form to the best of his/her knowledge and capacities. I expressly confirm that my decision to return to competition following the incident is an entirely free personal decision which does not rely on the assessment as providing me with any reliable assessment of my actual health condition. I do expressly confirm that I accept all risks and liabilities linked with my participation in the given circumstances and which might arise out of injuries that I may have been suffering, whether or not objectively detectable at the time.

If the assessment outcome is that a medical evaluation has to be performed and I still want to continue to compete, I agree that as a condition for my possible returning to competition, I must submit to a formal examination by a qualified doctor and that I can only return with formal medical clearance declaring me fit to participate after such evaluation. If such clearance cannot be obtained in time for any reason, I accept that the FAI Controller may refuse my further participation in the competition. I understand and agree that it is my responsibility to seek medical support for the purpose of this evaluation. Whilst medical services may be available for purposes such as first aid in case of injuries or health issues at the Competition, neither the FAI nor the meet organisers have an obligation to provide access to medical evaluation services for the specific purpose of the above clearance. The medical evaluation is to be conducted under the sole professional responsibility of the medical professionals who accept to perform it.

I agree to release and hold harmless the FAI and its officers, FAI officials including specifically but without limitation the FAI Controller and all Competition officials from claims arising out of or in connection with my return to or exclusion from competition in the circumstances contemplated in this form.

This declaration including without limitation the above release and indemnity is subject to Chinese Law.
