10/07/2108	2018/15	<p>The bid received from Belgium to host the 2020 FAI World Cup and European Championships in Indoor Skydiving contained an error in the entry fee. The sanction fee was omitted and this was picked up during the presentation at the IPC Plenary. It was approved by all delegates that the entry fee could be adjusted accordingly. At the last IPC Plenary it was approved to increase the number of judges required to judge the Indoor Artistic Events from 8 to 12. As this increase has an impact on the organiser budget, the Belgian NAC requested to adjust the entry fee to take this into consideration spread over all disciplines.
